Sample ByLaws for a Condo Association or HOA

A homeowner association is typically a nonprofit corporation that is created by a developer - when a community is in the planning stages and prior to sale of the first home. Membership in the homeowner association is mandatory. The association is governed by a board of directors which initially is the developer and his representatives.
