### **The Revised Uniform Fiduciary Access to Digital Assets Act**

Provide a fiduciary or designated recipient a copy in a record of any digital asset that, on the date the custodian received the request for disclosure, the user could have accessed if the user were alive and had full capacity and access to the account.

### **Revised Uniform Fiduciary Access to Digital Assets Act; SB 63**

(a) If a fiduciary with a right under this [act] to access a digital asset of an account holder complies with subsection (b), the custodian shall comply with the fiduciary's request in a record for: (1) access to the asset; (2) control of the asset; and (3) a copy of the asset to the extent permitted by copyright law.
